The town had received a letter from MRC asking for letters of support. This is a part of a new integrated solid waste facility that would be located in either Argyle or Greenbush, Maine. This is due to the expiration of the contract with PERC in 2018. The Board signed the letter of support.

Chairman Alton Grover announced that he contacted Morton Salt, the new salt contractor, and found out that they will not have any salt available until September.
