### 7a. Renew Moratorium Ordinance Regarding Retail Recreational Marijuana

**ACTION:** Selectman Laurie Haynes made a motion to extend for 180 days the Cushing Moratorium Ordinanance Regarding Retail Recreational Marijuana that had been in place since October 23, 2017. Selectman Martha Marchut seconded.

**Discussion:** The moratorium ordinance currently in place was due to expire on April 20, 2018. The extended ordinance would last until October 17, 2018. MMA had gone over the requirements for extending a moratorium. The new document, approved by the Selectmen and to be signed by Cushing Town Clerk Lisa Young, met the state requirements for such an extension; namely, that the situation that gave rise to the current moratorium was still in effect, and the ordinance committee had made progress toward a solution.
