8. Comments from Citizens:

ACTION:

Discussion: Craig Lord would like to talk more about the drudging be proposed on Sandy Lane of Rt 97. Bill Gray felt that the state was just pushing this through, we are getting taking advantage of. Bill and Craig said they submitted some questions to the State. This was put in the paper as well as all abutters were notified on Sandy Lane. The response that they received from the State said that "the notice does not say hazardous chemicals will be used as far as the proposed activity." Craig said that both Vinalhaven and Rockland Harbor dumping contained high levels of Arsenic and Led, levels that are unsafe. They both felt that the board should stop this. The permits have been issued but he thinks there is away to appeal those. There is a time deadline though. Bill also said that not only are they dumping but there will be an estimate of 35-40 trucks a day hauling the waste in and out of Rt 97 and Sandy Lane. Craig Lord wants to know if there is an appeal process at this point. Craig Curry is happy to send them an email, also talk with MMA about the appeal process. Alton also said that another alternative would be to contact Ann Matlack. Craig Lord said there was a lot of miss facts in the ad stating that the property is fenced, which it is not, there's kids running ATV's all over there.
