

In January, I was privileged to take the Oath of Office to begin my second term as your Governor. I am deeply humbled by the trust the people of Maine have placed in me, and I look forward to continuing to work hard over the next four years to improve the lives and livelihoods of Maine people.

Over the past four years, we have made real progress. We have expanded health care, leading to the largest decline in the uninsured rate of any state in the nation. Dear Friends:

It is an honor to represent Maine in the U.S. Senate. I am grateful for the trust that Mainers have placed in me and welcome this opportunity to share some key accomplishments for our state.

Last year, I secured more than \$500 million for 285 projects from Aroostook County to York County that will promote job creation, workforce training, and economic development; expand access to health care; improve public safety, infrastructure, and community resources; and protect our environment. To address the crisis of soaring inflation and high energy prices, I led efforts to provide \$2 billion in supplemental funds to the Low-Income Home Energy Assistance Program. In the new Congress that begins in 2023, I expect to be the Vice Chairman of the Appropriations Committee and will continue to champion investments to support Maine's communities and families.

Strengthening our economy and supporting good jobs remain a top priority. Along with the Governor and the rest of the Maine Delegation and the associations representing the lobster industry, I worked to protect our hardworking lobstermen and women by pausing for six years the onerous federal regulations that jeopardize our lobster fishery's very existence. Another ongoing threat to Maine's small businesses is the shortage of workers. That's why I led an effort to push the Administration to nearly double the number of H-2B visas that are critical to our hospitality industry. Additionally, when the Administration proposed to cut the construction of a destroyer to be built by Bath Iron Works, I restored this funding to protect Maine jobs and our national security.

When Maine Veterans' Homes announced last year that it planned to close its facilities in Caribou and Machias, I opposed that decision which would have had such a devastating effect on rural veterans and their families. I am glad that the decision was reversed, and I have secured \$3 million to help with upgrades to these facilities. My *AUTO for Vets Act* also became law, which will help disabled veterans maintain their independence by supporting the purchase of a new adaptive vehicle once a decade.

This past year, Congress demonstrated how effective it can be on behalf of the American people when both parties work together. A few of the bipartisan achievements that I was involved in include the *Respect for Marriage Act*, which will provide certainty to millions of loving couples in same-sex marriages while protecting religious liberties, and the *Electoral Count Reform Act*, which establishes clear guidelines for our system of certifying and counting electoral votes for President and Vice President.

No one works harder than the people of Maine, and I have honored that work ethic by showing up for every vote. During my Senate service, I have cast more than 8,500 consecutive votes, never having missed one.

I remain committed to doing all that I can to address your community's concerns in 2023. If I may be of assistance to you in any way, I encourage you to contact one of my six state offices.

Dear Friends,

I've often thought that Maine is just one big small town connected by long roads. Well, in the past year or two, those roads have gotten steeper and bumpier as we dealt with an unprecedented pandemic and the resulting economic troubles.

As we faced the historic challenges, something impressive happened. We came together and lent a hand to our neighbors wherever we could to keep things running and spirits high.

Down in Washington, Congress tried to help Maine communities get through this struggle, so that our state would come out stronger. To do that, we put in the work and set some things into motion that are already helping Maine people. That's why you hired us, after all.

The pandemic made something we'd known for a while clear: those roads and networks that connect our big town needed repair, improvements, and expansion – from bridges to broadband. So, while Maine was uniting towards a common purpose, Congress came together to pass the *Bipartisan Infrastructure Law* – legislation that makes generational investments in physical infrastructure, broadband connections, harbors, and the energy grid. These efforts will lay the foundation for Maine's 21<sup>st</sup> century economy and make sure even the most rural areas aren't left behind.

Over the last two years, as we drove up and down our state, you couldn't help but see storefronts in trouble and prices rising as the economy struggled through a global recession. And again, while you focused your efforts on getting through the difficult times, Congress took meaningful action. We passed the *American Rescue Plan* in 2021, which enabled Governor Mills and the state of Maine to better meet the health and economic difficulties of the pandemic. At a critical moment it expanded healthcare efforts to confront COVID and invested in the state to keep the economy in far better shape than most others nationwide.

Congress didn't stop there. This year, we took even more concrete steps to cut costs, create jobs, and provide more affordable, cleaner energy. The bipartisan *CHIPS Act* will bring home the manufacturing of the technical components known as "chips" that are used in everything these days – from smartphones to microwaves to cars – and in doing so reduce prices and create good American jobs. We also passed the *Inflation Reduction Act (IRA)* to lower healthcare costs, allow Medicare to negotiate drug prices, and cut energy bills with new rebates for things like heat pumps and solar panels.

Beyond these major investments, we also passed vital legislation to improve the day-to-day lives of Maine people and Americans nationwide. On a bipartisan basis, we expanded health care for veterans exposed to toxins, strengthened protections for marriage equality, supported Ukraine as it fought off a bloody Russian invasion, secured our elections and the peaceful transfer of power, and delivered millions in federal investments to projects up and down our state.

So, as Maine worked to get through hard times, Congress took steps to support our state – and we're already starting to see brighter days ahead. I'm proud to have played a small part down here; it's a true privilege to listen to you, work with you, and build a brighter future for all the incredible people up and down the roads that connect our big small town. Mary and I wish you a happy, and safe 2023.

I hope this letter finds you well. It is my honor and privilege to serve the people of Maine's First District in Washington, DC, and I appreciate the opportunity to share this annual update with you.

This past year, our state faced unprecedented challenges, mirroring the difficulties experienced by communities across the nation. High inflation rates, a rapidly changing climate, aging infrastructure, and increasing energy costs were among the top concerns I heard while home in the district. Keeping these in mind, I was proud to work with my colleagues in the Maine Delegation to pass historic legislation to bring federal dollars back to our communities.

One of the ways we delivered for Mainers was through the passage of the Inflation Reduction Act (IRA) in August. This law provides much-needed assistance to struggling families. With the help of the IRA, Americans will save an average of \$800 per year on health insurance and Medicare beneficiaries will have increased access to medication.

Additionally, the IRA offers billions of dollars to expand rebate programs for Americans who wish to make their homes more energy efficient. Homeowners can now receive up to a 30 percent tax incentive for the cost of home solar installations and a 30 percent incentive when investing in a heat pump. Over the next decade, these rebates will offer Mainers thousands of dollars in savings while decreasing fuel costs for winters to come.

In 2022, Congress also passed meaningful legislation to help create skilled jobs in the construction, manufacturing, and engineering sectors. The Creating Helpful Incentives to Produce Semiconductors (CHIPS) Act will allow the U.S. to advance its leadership in the development of semiconductors used in the manufacturing of computers, cell phones, cars, and numerous other technologies we rely on. By developing this industry at home, we can bolster our national security and lessen our reliance on foreign technology.

As I look toward this Congress, I am excited to work with my colleagues on both sides of the aisle to improve the lives of Maine people. It is critically important that we continue to take action to increase job growth, decrease inflation, take measures to promote our national security and invest in our health care and education systems.

Each year my office receives over 40,000 calls, letters, and emails from Mainers. I recognize the tremendous trust you place in having me represent you in Washington and by sharing your stories, thoughts, and concerns. Please rest assured, I will continue to fight for the interests of Mainers in Congress, and my staff and I will do everything we can to ensure your needs are met.



### Cushing Fire Department Annual Report 2022

For the first time in a few years things have started to get back to normal when dealing with covid. We were able to have all our meetings/training in person. Cushing hosted a joint Central Main Power training class with Friendship to learn the importance around downed power lines and scene safety. This was very informative and a great way to train with one of our mutual aid departments.

Fail Safe again tested all our hoses and ladders. All equipment passed other than a few sections of hose that have sense then been replaced. All equipment now passes State requirements.

With great excitement our newest firetruck arrived in April ahead of schedule. This apparatus is now known as Cushing Tanker One. Along with Cushing Rescue, we held an open house at the Fire station after the arrival of the new apparatus. This gave towns people a chance to come down and view the new additions. There were approximately 40 individuals who took advantage of this opportunity to view and ask questions. Tanker One has been proven to be a great asset to Cushing Fire Department as well as to our neighboring town's during a mutual aid need. Greenwood again came down and did our pump testing on 2 fire trucks. Engines 1 & 2 Both passed.

October 21<sup>st</sup>, we were able to do in person fire prevention at the Cushing Community School. The kids had lessons on fire safety in the home. They were taught about the fire truck and equipment and given some fun take home items. There were some fun activities and even smokey the bear joined us.

Please make sure that your house address is visible so emergency personnel can find your address quickly. Teach your children their address so in the event of an emergency they can give dispatch the correct address. Practice fire drills at home and have a meeting place outside. Agree on a way for a member of your family to report to the fire department that everyone has got out of the home safely. Check your smoke detectors every month and change the batteries in them every 6 months. If anyone is needing help installing detectors or have questions, please contact a member of the fire department or the Town Office and they can get in touch with us. Carbon Monoxide alarms are also a good idea to have. If your alarm goes off, please leave your home, and call 911. It may be something as simple as it is needing a new battery but let us make that determination. Carbon Monoxide is a gas that is odorless and deadly. Please don't ever assume your alarm going off is just a machine issue, it could be the difference between life and death. We also ask that anyone who has camps or summer homes that have become more year around residence that you make sure that the roads to these structures are accessible to emergency vehicles. This means that the road is clear of tree's and wide enough to allow an emergency vehicle to get through. If you are at these homes in the Winter months, we would also ask that you make sure the roads have been plowed and sanded if need be.

Burn Permits can be obtained through both Maine Forestry and Wardens Report Websites. Please make sure to always have your permits in hand as well as the appropriate items required to put your fire out quickly if need be.

We had another successful pig roast. We look forward to doing it again in 2023. A Hugh thankyou to Shawn and Sarah Hiller of Hiller's Market for the generous donation of a pig for this event, it was greatly appreciated.

Three-day supply of water (1 gallon per person/per day) Non-perishable food, and non-electric can opener First aid Kit along with any prescription medication Battery powered radio Flashlight with plenty of extra batteries

Assemble your needed supplies and store them together in a central location.

# \* \* \* IS YOUR HOUSE NUMBER VISIBLE? \* \* \*

For privacy reasons all dispatch information is given in relation to a property address only, no names are used over the air. For this reason, it is important that all properties are clearly identified with numbers visible from both directions on the street. The town requires that you have reflective street numbers, 4 inches high, preferably on your mailbox. Crews and ambulances may be coming from either direction. In addition, for serious events, mutual-aid ambulances may be coming from out of town and those drivers will not be familiar with the area. Clear numbering may be critical in ensuring the earliest possible treatment. When you drive home at night, look at your mailbox. Can you see your number? No? Either can we.

# TOWN OF CUSHING BOARD OF ASSESSORS ANNUAL REPORT FOR THE YEAR 2022

The real estate market for the last two years has set records for both numbers of sales along with sale prices countrywide as people have fled cities for more rural markets. Cushing's rural coastal nature has been very attractive to many new home buyers as can be evidenced by our rapidly declining sales ratio which is putting the town in a precarious position where our sales ratio will likely not meet the State's minimum assessing standards for fiscal year 2023. Our current sales ratio is 98% with a quality rating of 17 (State Minimum Standards are 70% for sales ratio and 20 for quality rating) developed utilizing sales from 2020-21. Preliminary calculation of the sales ratio for 2021-22 puts us nearer to 78%. We were hopeful that the increase in interest rates by 3.5+% over the past year might assist us with a natural market correction, but as that has yet to materialize, it will require our Town look at different revaluation options or risk losing state funding for schools, revenue sharing, and reimbursements such as the Homestead Exemption, Tree Growth and the newly adopted Stabilization legislation for over age 65 taxpayers.

In any case, the Assessors are working hard with their Assessing Agent reviewing new construction, processing deeds, updating our new digital tax maps and entering exemption/use value applications along with tracking this volatile market and property tax legislation that may affect Cushing taxpayers.

As a yearly reminder there are number of property relief options available for taxpayers with both information/applications being found on our Agent's website at <u>www.maineassessment.com/relief</u>.

The Planning Board meets on the first Wednesday of each month at 6:00 pm if there are applications to review. These public meetings will be posted at least a week in advance of the meeting. The Board, consisting of five members, reviews applications as required by the Cushing Shoreland Zone Ordinance and the Subdivision Regulation. Work sessions are held as needed.

In continuing its work of rewriting the Shoreland Ordinance to bring it in compliance with State recommendations, the Board held numerous work sessions to come up with changes required by the State and to correct errors, omissions, and provisions no longer appropriate in the Town's Ordinance. When this work is completed, we will hold citizen information meetings to explain the changes and request comments and suggestions before bringing it to a Town Meeting for citizen approval.

Meanwhile the Board has been reviewing and adjudicating applications from homeowners and subdivision planners.

We have received new digital maps of our town and a mapping company has superimposed property lines and other town features on newly printed maps available for consultation in the town office. We are also getting geared up to eventually make enhancements and layers on digital maps that can be viewed on the Internet.

# **Report of the Plumbing Inspector for 2022**

State Law requires that a licensed plumber is required for all internal plumbing installations. Except a homeowner may obtain a permit and do the plumbing in his/her own residence only but it shall meet the Plumbing Code requirements. Plumbing requiring a permit shall not be done by the owner in dwellings that are being rented or the owner does not occupy.

Any plumbing done without the required permit shall be penalized by a double fee, hidden plumbing without the required inspection shall be exposed and possibly removed for the visual inspection (including insulation and sheetrock removal in some cases), and the piping tested as required by the code. Ask your plumber to see the plumbing permit **prior** to the project starting.

Records of septic systems and internal plumbing are retained at the Town Office if you need a copy. Older systems may not be on record. The state also retains a copy of internal and septic systems.

There is a Plumbing Code book in the Planning Office if anyone would like to look it over for installations and "how too" for their project.

Call me if I can answer any questions related to plumbing or septic systems or parts there of.

# Cushing Harbormaster 2022 Annual Report

A special thanks to those vessel operators who exercised a high degree of professionalism throughout Cushing waters. There are a negligible number of incidents here. We do have a few holdouts, commercial and private, who seem oblivious to the need for caution. I would remind all that these are commercial fishing waters. I ask all vessels to exercise caution around active lobster boats where the busy crew may be briefly unaware of a nearby vessel. Similarly, I ask our larger boats to reciprocate when it comes to speed and wake.

# Wandering Boats & Floats

This past year I have again experienced a significant number of inquiries regarding loose floats or boats ending up on residents' properties. I reiterate that the town does not remove flotsam and jetsam put ashore by the sea regardless of the degree of negligence or purpose that cast it adrift in the first place.

Boats have hulls numbers which should be registered and permitted floats should have a permit identification painted somewhere, clearly visible. I will attempt to identify and locate the probable owner and ask them to remove the boat or float. Often ownership cannot be determined.

# Unregistered Boats.

This past year a loose boat was beached without a registration or current sticker, even though the boat was obviously one that should have been registered and annually paid excise tax for at least 10 years. Selfishly, this owner expects the rest of us to pay his share, and I suspect he is not alone. So please heed this warning – unregistered boats are not permitted in Cushing or any Maine waters. Boat registration fees and excise tax pay for facilities and services that all use, no matter how small.

# **Unpermitted Moorings**

As always, I need to remind mooring owners that registration and an approved permit is a required. The town is mandated by the state to register all moorings which have been laid on State Submerged Lands – MRSA Title 38, Chapter 1, Subchapter 1, §3. The regulations for moorings may be found in the Town of Cushing Coastal Waters Management Ordnance. Many residents still ignore these simple rules. I am about to retire from business and will have a lot of time on my hands, some of which I just may use to enforce this ordinance. Just register your mooring and get a permit.

# Please observe all navigation buoys, speed limit markers and ordinance defined zones.

# **REPORT OF THE ANIMAL CONTROL OFFICER**

# 2022

As the Animal Control Officer, I am responsible for domestic animals, I am not responsible for wildlife. The Inland Fisheries and Wildlife number is 287-8000. They have revolving game wardens who cover multiple areas.

The State of Maine requires all dogs over 6 months of age be current with their rabies vaccines and licensed with the town.

A dog license is issued each calendar year, January 1- December 31. The start date for registering is October 15th. Registration fees are \$6 per altered dog and \$11 per unaltered dog. You can go directly to the town office, call the town office to register, or you can register online at Maine.gov/online/dog license. There is a small fee if you pay over the phone or register online. Maine charges a late fee of \$25 PER dog beginning Feb 1.

As we move forward with technology, I highly suggest checking the town's website as they post all the upcoming news, events, and such. Also, if you have Facebook there is a Town of Cushing Message Board. If you have a missing animal, or have found one, the FB page is very useful for all of us. I also use it to post upcoming Rabies or spay/neuter clinics in our area.

There is no leash law regarding cats.

# **CUSHING PUBLIC LIBRARY ANNUAL REPORT**

Dear Cushing Board of Selectpersons:

The Board of Trustees is grateful for the past support the town of Cushing has provided to our community-based library, where we offer free services and programs for all residents of Cushing. We are writing to ask for \$2,500 to continue to maintain and improve the library's collections and services.

We are happy to inform you that we did not need to close the library due to COVID at any time during this past year! We remain cautious about COVID, and will keep you informed of any future changes, if necessary. We are committed to keeping the library open while following recommended health and safety practices.

Due to the addition of two new volunteers, we increased our open hours on Mondays, added evening hours on Wednesdays and resumed our Saturday hours. For those who are unable to visit the library, curbside pick-up service is still available. Both of our patron computers are available for free use. The community can also access our WIFI service on a 24/7 basis from outside the library by following information posted on the outer door.

As always, we hosted programs for children and families this year, including Preschool Story and Craft Time and the Summer Reading Program. The Easter Egg Hunt was a huge success – over 70 adults and children attended. Recently, we hosted our Annual Holiday Event, which included ornament making and a visit from Santa. The library also partnered with the Cushing Community School's Book Fair by providing each student with funds to purchase books.

The library continues to serve our community by offering diverse and interesting programs, in person or on Zoom, free of charge. We have been very successful in finding and hosting knowledgeable, stimulating speakers. Attendance at our events remains strong. This year, we hosted another online reading group for adults on Zoom. This free "Discussion Project" program, sponsored by the Maine Humanities Council, was led by a trained facilitator. Other remote presentations have included programs about British Mystery Writers and the Boston Red Sox.

We were able to offer more in-person programs this year. Several Maine authors discussed their most recent books, and Cushing artist Alan Magee presented a film about his work. We hosted two Night Sky Watches at the Good Neighbor Park and sponsored our second Community Craft and Yard Sale.

We have maintained our involvement with the internationally renowned Camden Conference, whose mission is to foster informed discourse on world issues. The theme for 2022 was *Global Trade and Politics: Managing Turbulence*. We hosted the first of two outstanding Camden Conference programs on Zoom in November, and will offer the other in January 2023.

One of our most successful undertakings has been our collaboration with the Thomaston Public Library. By sharing the cost, Cushing and Thomaston have been able to attract popular speakers which would not be affordable for the individual libraries. In June, the Chewonki Foundation brought an exciting family program about predators to Cushing. In August, Maine author Paul Doiron visited Thomaston to discuss his latest book. Many community members from both towns attended these events. We will continue this partnership in the coming year.

Information about the Library, including schedules, activities and new media purchases can be found at our website: <u>www.cushing.lib.me.us</u>. From this web site, patrons can link to the Maine InfoNet Download Library and select from thousands of audio and e-book titles without charge.

While the Board of Trustees seeks grants for book purchases and special events, conducts an annual appeal, and contributes, in addition to their time, to the finances of the library, we cannot meet all expenses in this manner. Because we have no paid staff, the town funding goes directly into services for Cushing residents and children. We appreciate the town's support of the library as a place where community, learning, fun, and imagination can happen. For all of these reasons, we respectfully request continued support in 2023.

# 2023 Cushing Recycling News

The Cushing-Friendship-Waldoboro Transfer Station (CFWTS) reports that residents are preparing their recyclables well.

The trash haulers, though, want to emphasize that some households are co-mingling all recyclables into one bin. Recycling in our town is NOT SINGLE STREAM. Households should pre-sort their recyclables. Your trash haulers cannot take the time to sort your recyclables for you.

**REMEMBER:** at this time the only plastics accepted at the Transfer Station are HDPE (#2 plastics), **RIGID PLASTIC**, and **GROCERY STORE PLASTIC BAGS** 



Look on the container's bottom for the chasing arrows recycling symbol containing the identifying #2 HDPE.

#2 Milk Jugs ("natural color" HDPE) plastics should be kept separate from other "colored" #2 HDPE plastics such as laundry or dish detergent jugs

RIGID PLASTIC: buckets, soda crates, plastic toys, plant pots, kiddie pools, truck liners are still being recycled at CFWTS.

- Universal Waste: batteries, car batteries, alkaline batteries, rechargeable batteries, watch and hearing aid batteries, etc.
- · Electronic Waste: computers, printers, TVs, radios, etc.
- Fluorescent and CF bulbs, thermostats, ballast, all other light bulbs
- Oversized Brown Waste such as couches, chairs, mattresses, rugs, etc.
- CDD construction/demolition debris
- Brush, trees smaller than 6" in diameter
- Appliances
- Tires

# Important suggestions from our trash haulers:

# HOW TO PREPARE WHAT YOU PUT INTO THE RED RECYCLING BIN

- ★ MOST IMPORTANT: Each household is responsible to *pre-sort the recyclables*. *Do not co-mingle* the recyclables. We are *not* single-streaming.
- ★ Bag like-items for easy pick-up by the hauler. Do not seal any bags containing recyclables.
- ★ #2 plastic must be kept separate. Plastic shopping bags are recycled at CFWTS, Hannaford, or Shaw's.
- ★ The following items are *Not Recyclable*: Kitchen plastic wrap, Boat Shrink Wrap, Styrofoam trays nor Foam Peanuts. They must go into the trash.
- ★ All *rinsed* metals, tin cans, aluminum can go into one bag.
- ★ UPDATE: Newspapers/Magazines, Mixed papers, and all Books go into one bag.
- ★ TETRA PAKS ARE NOT RECYCLED: juice, milk, broth, soup containers should go into the regular trash because their multiple layered construction is too difficult to recycle. So, put TETRA PAKS into the trash.
- ★ Leave paint in cans; do not seal into bags. CFWTS participates in a state-wide paint recycling program and CFWTS accepts oil and latex paints *without charge*.
- ★ CFLs or fluorescent light tubes must be protected from breaking.
- ★ Take used motor oil to be burned in Prior Garage's waste oil furnace in Cushing.

# Dog Waste in the Watershed

The Georges River Shellfish Committee would like to inform you of our ongoing conservation efforts to protect the health of the St. George River to promote and prolong the shellfish in our river and our swimmers. We have *one* major request of the people who live along the river and inland, and that is to remove your dog waste in an environmentally safe way. When dog waste is left on the ground, it becomes a pollutant, and a human health hazard, washing into the waterways, rivers, streams, creeks, and other local waterways. The Shellfish Committee does regular DNA testing to pinpoint pollution sites. Almost every site tested resulted in dog waste being the number two pollutant in the St. George River.

Dog waste is an environmental pollutant. In 1991 it was labeled a non-point source pollutant by the EPA, placing it in the same category herbicides, insecticides, oil, grease, and toxic chemicals.

Beyond your grass, it has been estimated that a single gram of dog waste can contain 23 million fecal chloroform bacteria which can cause cramps, diarrhea, intestinal illnesses and serious kidney disorders in humans and animals. In addition, dog waste is the common carrier of whipworms, hookworms, roundworms, tapeworms, parvo, salmonella, and campylobacter. The EPA estimates that two- or three-days' worth of droppings from about 100 dogs would contribute enough bacteria to temporarily close a bay and all water sheds within 20 miles of it for swimming and shellfish harvesting.

Some algae blooms are the result of an excess of nutrients, particularly phosphorus and nitrogen. These higher concentrations of these nutrients in water causes increased algae and green plants. With more nitrogen available, the bacteria increase in number and uses up the dissolved oxygen. Nitrogen and phosphorus are in fertilizer and dog waste.

Everywhere the Georges River Shellfish Committee has done water testing in the river has come back as having a significant amount of dog waste. So please dispose of your dog waste in a reasonable manner by putting the waste in a bag, sealing it, and putting it in a garbage/disposal can. None of us wants our guests, grandchildren, or children to get sick from our river when enjoying our local Maine waters.

This is 20% more than last year due to an increase in staff salaries to meet cost of living needs and an increase in staff travel reimbursement.

New Hope Midcoast is a member of the Maine Coalition to End Domestic Violence (MCEDV). We employ trained staff who seek to empower clients to make their own decisions throughout their journey toward safety and self-sufficiency. Our free, comprehensive services include a 24/7 helpline, hospital accompaniment when injury is incurred as a result of domestic abuse, support groups, legal advocacy and support services, a dedicated staff in Child Protective Services to address the needs of families affected by domestic abuse who have children, emergency sheltering, long-term transitional housing with the opportunity to work toward financial stability through our collaboration with New Ventures Maine, and trainings and presentations for schools, businesses, healthcare providers and civic organizations.

We recognize that abuse not only affects the individuals and families that directly experience it and believe in a coordinated community response to domestic abuse. Along with the aforementioned collaborations with schools, civic organizations, New Ventures Maine and Child Protective Services, New Hope Midcoast regularly works with area food pantries, animal shelters, law enforcement, legal professionals, homeless coalitions, and healthcare professionals.

In the past we have offered data on the direct services provided specifically to clients from your town. Unfortunately, doing so conflicts with the confidentiality requirements of our federal funding sources. This is particularly true for small towns with relatively few residents where maintaining confidentiality can be challenging. We hope that you will find this Knox County data helpful as you make your decision: NHM served 347 clients this year totaling 1,111.8 hours. We provided 609 nights of shelter for those who chose to leave their circumstances and provided 343.15 hours of community education and prevention for 989 individuals.

We enclose our financials, and are pleased to provide any other non-identifying information as requested. The stakes are high. Communities simply cannot thrive when individuals and families are hurting. Thank you for your consideration as we continue to work with all in need.

#### OPINIONS

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, each major fund, and the aggregate remaining fund information of the Town of Cushing, Maine, as of December 31, 2022, and the respective changes in financial position for the year then ended in accordance with accounting principles generally accepted in the United States of America.

#### **BASIS FOR OPINIONS**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Town of Cushing, Maine, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

#### RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

#### SUPPLEMENTARY INFORMATION

Our audit was conducted for the purpose of forming opinions on the financial statements that collectively comprise the Town of Cushing, Maine's basic financial statements. The combining nonmajor fund financial statements, schedule of property valuation, assessments, and appropriations, schedule of taxes receivable and schedule of departmental operations are presented for purposes of additional analysis and are not a required part of the basic financial statements. Such information is the responsibility of management and was derived from and related directly to the underlying accounting and other records used to prepare the basic financial statements. The information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the combing nonmajor financial statements, schedule of property valuation, assessments, and appropriations, schedule of taxes receivable and schedule of departmental operations are fairly stated, in all material respects, in relation to the basic financial statements as a whole.

Art. 41. To see if the Town will authorize the Select Board to dispose of tax acquired property by sealed bid, and to advertise the sale of the property three times in the local paper, prior to the opening of the bids.

Art. 42. To see if the Town of Cushing will vote to authorize the Select Board to appropriate \$135,182.97 from Coronavirus Local Fiscal Recovery Funds (aka American Rescue Plan Act or ARPA funds) received by the Town from the Federal Government for purposes they deem advisable so long as they adhere to the specific terms and conditions that limit the use of the fund.

Art. 43. To see if the Town will vote to accept the various State Reimbursements, such as Municipal Revenue Sharing Funds, Tree Growth, Veteran's Tax Exemption, Urban Rural Initiative (road fund), Fuel Tax Refund, Snowmobile Refund, General Assistance, Small Community Grant Program, and all kinds of property relief as provided by the State Legislature to the Town in the fiscal year 2023.

Art. 44. To see if the Town will vote to accept and appropriate, for the purposes for which they are received, the proceeds of all grants made to the Town during the Town's fiscal year by the federal or state government, their agencies and authorities; and to see if the Town will vote that any necessary matching funds be appropriated by Town Meeting and that any substantive conditions other than a standard grant condition regarding spending only for the purpose for which the grant is made, be approved by Town Meeting.

Art. 45. To see if the Town would vote to increase the property tax levy limit established for the Town of Cushing by State law if the municipal budget approved under the preceding articles will result in a tax commitment that is greater than the property tax levy limit.

Art. 46. To see if the Town will vote to authorize the municipal officers to dispose of town-owned personal property under such terms and conditions as they deem advisable.

Art. 47. To see if the Town will vote to authorize the Select Board to accept, on behalf of the Town, gifts, donations, trust funds, and contributions in the form of money, personal services, and materials for the benefit of the Town, its government including legal departments and public facilities thereof, for the purpose of aiding and enhancing the delivery of public services. Said gifts to be without conditions and not require the voters to raise additional maintenance money.

Art. 48. To see if the Town will vote to authorize the Select Board to borrow money in anticipation of tax receipts and to borrow or transfer funds as they deem advisable to meet unanticipated year 2024 budget accounts from January 1, 2024, until the 2024 annual meeting.
