# 7a. Annette Naegel and Hannah Blunt from the Georges River Land Trust to update the Board on the Langlais Preserve

#### 7d: Revaluation of Cushing

#### ACTION:

**Discussion-** As chairman of the Board of Assessors, Bill Aboud proposed to the Select Board that he'd like to make a case for a whole town property re-evaluation. He said,

our professional Assessor's Agent, Garnett Robinson, estimates that this year we'll be able to certify at 86% instead of 100%, which means we'll get state re-imbursements reduced by 14% this year. While this is not good, the real bad news is next year if we do nothing, we will fall below 70% and that will be very bad for state reimbursements. An additional issue is our quality rating, which is moving towards 20. This is a statistical evaluation of how our assessments deviate from a norm and measures the internal fairness of our assessments. At a quality rating of 20, there will be many property owners paying more than their fair share and many less. We need to fix this for the sake of our property owners.

Bill offered and discussed several possible options to forestall a whole town reassessment but recommended as the best option to take the hit coming from certifying at 86% this year but hire a firm to begin the re-evaluation immediately after we certify our property values in July and have them finish next June in time for us to recertify at 100%. That way we make only one adjustment as appropriate for all properties instead of piecemealing and making several adjustments which upsets taxpayers.

Mr. Aboud then offered to prepare an RFP for the Select Board to approve and send out for bids. He estimated that there are approximately 1,300 taxable properties in Cushing and the cost for re-evaluating them will be in the neighborhood of \$100 each.
