Sealed bids labeled "Killeran Lane Repairs' will be accepted at the Cushing Town Office, until 2:30 P.M. on Friday, October 6, 2023. Sealed Bids will be opened on Tuesday, October 10 at the Select Board Meeting at 6:00P.M. Proof of insurance and independent contractor status (if needed) is required. The Town of Cushing reserves the right to accept or reject any or all bids in whole.
